

## **East Riding of Yorkshire Council – Environmental Control Section Public Health (Control of Diseases) Act 1984 - Section 46**

### **Information on the deceased:**

The Environmental Control (EC) team deals with the deceased for whom there is no one capable, willing or available to make the necessary arrangements. As part of the process, inquiries are made to ascertain whether there are any living relatives, but this will not include public notices. We will use information from the Police (who will usually be first on the scene) neighbours and other Council department's records, if available. Information may also be available from the Coroner and from family members. An EC officer may also visit the home of the deceased to search for a will or evidence of family connections etc.

### **EC contact details:**

No single officer is responsible for dealing with these cases – it will depend upon where the deceased lived within the district. The Council's Social Services team currently contract the EC team to deal with public health funerals under the Act for their client group.

### **Funeral contractor:**

The Council currently has a framework contract for the provision of funerals with:

Hannah Rose Funerals, Bridlington. The current framework contract commenced 1 April 2021.

The ashes will be retained for a period of 6 months from the date of the cremation and if not claimed during that time, will be scattered in the gardens of the crematorium.

### **Notifications:**

Depending upon the case EC officers may advise DWP, Council Tax and/or Council Housing teams of the death of a person.

Notices of the death/funeral and obituaries are not published in any newspapers – a church service is not provided.

If family or friends wish to make such arrangements having not undertaken to have the body interred or cremated, they make such arrangements at their own cost and the EC team will not be involved.

The EC team will arrange for a death certificate; will complete internal requisition forms (mainly electronic) for the procurement of the funeral; and the Treasury Solicitors forms as appropriate.

Hospitals within the East Riding may notify the EC team of a death in hospital where a public body may undertake to have the body cremated/interred, but only to seek help to gather information from the home of the deceased. The hospital's bereavement team may deal with deaths that occur in hospital that fall under the act.

### **The estate:**

The EC team do not accept responsibility for winding up the estate of the deceased. The officers will arrange for the cremation or interment and recovery of the council's costs from whatever assets are available then close the case. Qualifying bona vacantia estates are referred to the Treasury Solicitor.

### **Public health funerals undertaken in previous months:**

Details are given below of cases dealt with by the team. These details will be updated periodically if new cases have arisen. The exact address is withheld to protect the property left empty by the deceased, but this information is available through the Registrar's office if required.
